§ 6-101 CONDUCT OF ELECTION.

The election of city officials shall be conducted in all respects as provided by the laws of the state governing the holding of city elections.
(K.S.A. 25-2101 et seq.)

§ 6-102 HOURS OF VOTING.

At all city elections, the polls shall be open at 7:00 a.m. and close at 7:00 p.m., unless different hours are set and publicly announced by the County Election Officer.
(K.S.A. 25-2111, 26-206)

§ 6-103 TERMS.

(a) The Mayor and Commissioners shall be elected for four years; and at each election thereafter such officers shall be elected for terms of four years, and shall hold their offices until their successors are elected and qualified. The Mayor and four Commissioners shall constitute the Board of Commissioners of the city, and the Mayor shall be the presiding officer of the Board. Mayors and Commissioners elected in the year 1967 shall have terms expiring in 1971. Mayors and Commissioners elected in the year 1968 shall have terms expiring in 1973.

(b) The regular term of the Commissioner of Streets and Commissioner of Parks and Recreation shall be for four years commencing with the city election in April, 1983, and at each election thereafter the Commissioner of Streets and Commissioner of Parks and Recreation shall be elected for terms of four years, shall hold their offices until their successors are elected and qualified.

§ 6-201 DIVISION OF WARDS.

The city shall be divided into four wards, to be numbered Ward 1, Ward 2, Ward 3 and Ward 4, with the boundary lines as follows:

(a) Ward 1, beginning at the most easterly city limits at a point that would be an extension of the centerline of Main Street, proceeding west to the centerline of Washington Avenue, then south on an extension of the centerline of Washington Avenue to the south city limits, then following the city limit boundary to the east and north to the point of beginning;

(b) Ward 2, beginning at the center of the intersection of Main Street and Washington Avenue, proceeding west on an extension of the centerline of Main Street to the west city limits, then following the city limit boundary to the south and east to a point on an extension of the centerline of Washington Avenue, then north on the centerline of Washington Avenue to the point of beginning;

(c) Ward 3, beginning at the center of the intersection of Main Street and Washington Avenue, proceeding west on an extension of the centerline of Main Street to the west city limits, then following the city limit boundary to the north and east to a point on an extension of the centerline of Washington Avenue, then south on the centerline of Washington Avenue to the point of beginning; and

(d) Ward 4, beginning at the most easterly city limits at a point that would be an extension of the centerline of Main Street, proceeding west to the centerline of Washington Avenue, then north on an extension of the centerline of Washington Avenue to the north city limits, then following the city limit boundary to the east and south to the point of beginning.
