#### ORDINANCE #1551 NEMAHA COUNTY HEALTH OFFICER

Commissioner Norman Schmitt Jr. made a motion to approve Ordinance #1551. An ordinance amending in part portions of the current code of the City of Sabetha prohibiting the violation of an order of the Nemaha County Health Officer, and repealing any conflicting ordinances or resolutions setting a effective date. Commissioner Maridel Wittmer seconded the motion. The motion carried 5-0.

### RESOLUTION #2020-04 ADOPTION OF THE NEIGHBORHOOD REVITALIZATION PLAN

Commissioner Nick Aberle made a motion to approve Resolution #2020-04. A resolution designating a revitalization area and adopting a Neighborhood Plan for the City of Sabetha. Commissioner Julie Burenheide seconded the motion. The motion carried 5-0.

# RESOLUTION #2020-05 INTERLOCAL AGREEMENT, BROWN & NEMAHA COUNTIES, NEIGHBORHOOD REVITALIZATION PLAN

Commissioner Nick Aberle made a motion to approve Resolution #2020-05. A Resolution authorizing and directing the Mayor of the City of Sabetha to execute an interlocal agreement with the Boards of County Commissioners of Brown and Nemaha counties for the purpose of administrating the Neighborhood Revitalization Plan for the City of Sabetha. Commissioner Julie Burenheide seconded the motion. The motion carried 5-0.

### MIDTOWN CINDER BLOCK STORAGE BUILDING

City Administrator Doug Allen advised the Commission that a fair asking price for the Midtown Cinder Block storage building would be \$15,000. Discussion followed. It was the consensus of the Commission to sell the Cinder Block building to Jeff DeMint for \$15,000 with the stipulation the building must come down.

## WATER PLANT IMPROVEMENT PROJECT - FRONTIER SERVICES, INC.

City Administrator Doug Allen presented the bids for the water plant improvement project. Discussion followed. Commissioner Norman Schmitt, Jr. made a motion to approve on the recommendation engineers Schwab-Eaton, the low bid of \$1,629,684 from Frontier Services, Inc with the stipulation that liquid damages are included in the contract. Commissioner Julie Burenheide seconded the motion. The motion carried 5-0.
